DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. ALWAYS READ ENTIRE LABEL.

NOTE: Use of this product in any other way than recommended may result in serious injury to other crops or may result in forage crops containing levels of Molybdenum (Mo) which are toxic to ruminant animals. Also contains Boron which may cause injury to some crops.

SUNBurst Liqui-Iron can be applied to all vegetables, fruit trees, nut trees, vines, flowering and ornamental trees, shrubs, flowers, containerized plants, and turf. Apply as a soil drench or a foliar spray. **SUNBurst Liqui-Iron** can also be applied in irrigation water or surface applied.

Fruits and Vegetables: Use 1 to 3 quarts per acre.

Nursery: Use 1 ounce per gallon of water. Apply as a soil drench or spray plant foliage to the point of runoff. Repeat as needed.

For Turf: **SUNBurst Liqui-Iron** can be applied in irrigation water or surface apply. Use 2 to 3 ounces per 1,000 square feet, whenever needed, based on soil and tissue testing. Use 5 to 50 gallons of water per acre as a carrier.

SUNBurst Liqui-Iron is non-phytotoxic when used as directed. Always test a small plot before large-scale application.

Compatibility: **SUNBurst Liqui-Iron** is compatible with most liquid fertilizers, insecticides, fungicides, herbicides and nematicides. Check the compatibility of untried chemical mixes. Always jar test when in doubt.

Use best management practices when applying **SUNBurst Liqui-Iron**.
