DIRECTIONS FOR USE

SHAKE WELL BEFORE USING. FOR COMMERCIAL USE ONLY.

SUNBurst Turf Fertilizer 9-1-4 is non-phytotoxic when used as directed.

Boom spray or inject into irrigation system at a rate of 4 ounces per 1,000 square feet every 30 days, OR 8 ounces per 1,000 square feet every 60 days during the growing season. Use a minimum of three (3) gallons of water per 1,000 square feet as a carrier. Irrigate after application.

Compatibility: **SUNBurst Turf Fertilizer 9-1-4** is compatible with most liquid fertilizers, insecticides, fungicides, herbicides and nematicides. Check the compatibility of untried chemical mixes using a standard jar test. Always jar test when in doubt.

Use best management and use practices when applying **SUNBurst Turf Fertilizer 9-1-4**. Use additional fertilizers as needed, based on soil and tissue testing.
